1. **The Government of Nepal has allocated funds or received a loan/credit/grant** from GoN towards the cost of **Construction of Mapya Dudhkoshi Rural Municipality Office Building at Khastap, Solukhumbu** and intends to apply part of the funds to cover eligible payments under the **Contract for Construction of Mapya Dudhkoshi Rural Municipality Office Building at Khastap, Solukhumbu, Contract No. MDRM/NCB/WORKS/2082/083-02**. Bidding is open to all eligible as per Section V of bidding document.
2. **Mapya Dudhkoshi Rural Municipality, Khastap, Solukhumbu** invites sealed bids or electronic bids from eligible bidders for the construction of **Construction of Mapya Dudhkoshi Rural Municipality Office Building at Khastap, Solukhumbu** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 8,70,00,000**
  - Minimum Work experience of similar size and nature: **Construction of at least one RCC building of amount NRs. 5,55,00,000 or above.**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit Bidder who chooses to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.
4. Bidders, submitting their bid electronically, should deposit the cost of bidding document Rs. 10,000 in the account as specified below.

Sealed or electronic bids must be submitted to the office **Mapya Dudhkoshi Rural Municipality, Khastap, Solukhumbu** through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00** noon on **2083/02/07**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2083/02/07 14:00** at the office of **Khastap, Solukhumbu**. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 23,00,000**, which shall be valid for 30 days beyond the validity period of the bid **120 days after the bid validity period**.
